

FOX 35's ORLANDO GLEE CLUB

Who Can Enter

1. Entrants must be legal Florida residents who are 13 years of age or older and have lawful access to the Internet and a valid e-mail address.
2. Employees of Oregon Television, Inc. and its stations, WOFL FOX 35, ("FOX 35"), WRBW MY 65, (collectively, "Sponsors"), their affiliated companies, advertising and promotion agencies, and the immediate family members of each are ineligible

How To Enter

3. No purchase is necessary to enter or win. Only one entry per person. The contest begins at 11:59pm local time on October 5, 2009 and ends on December 31, 2009. To enter, log onto myfoxorlando.com and click on the 'Contest' link and follow through to the on-line contest entry page. Entrants will be asked to enter their email address and password to their myfoxorlando.com account. If entrants do not have an account with myfoxorlando.com they will be prompted to create one before they can register to enter the contest.
4. To create an account, enter your email address and create a password, then fill out an online form with your name, address, phone number and age. Once you are registered, enter the contest by completing the on-line entry form and uploading a photo which represents why you should be FOX 35's Orlando "Glee Club" Student Performer of the Week and write a brief reason why in the field provided. The field limits how much you can type.
5. Photos must be submitted in JPEG format with dimensions at least 640 x 480. Entrants must have the right or permission to submit the photo; professionally taken photos are not permitted.
6. All submissions must be original and conform to Sponsor's then-current standards and practices and policies as established or determined by Sponsor in its sole discretion. Each Monday, of the contest beginning October 5, 2009 at 4:00pm, a panel of station employees will judge and select three (3) finalists from among valid entries received by 3:59pm that Monday based upon the following criteria: originality, best execution of the FOX 35 'Orlando Glee Club' idea and creativity. The decision of the judges will be final as to all matters, including, but not limited to, whether an entry is received timely, whether a winner is eligible, or whether a person entering should be disqualified.
9. The three finalists will be posted on myfoxorlando.com for the public to vote for their favorite. Voting will start each Monday at 5:00pm and last through Wednesday at 5:00pm during the contest period. You may vote as many times as you would like. The finalist that receives the most votes during that time will be named the FOX 35 "Orlando Glee Club" Student Performer" for that specific week. In the event of a tie, the Sponsor will randomly select a winner from among the tied entries. All entries not selected will remain eligible for all subsequent weeks of the contest.

12. The Winner will be notified by email/ telephone call each Wednesday at 5:05pm during the contest period. If a winner is under 18 years of age, then their parent or legal guardian must sign, complete and return a release and affidavit of eligibility at the time of notification.
