

Volusia County Fair Ticket Giveaway - November 2009

Giveaway Rules and Regulations

Who Can Enter

1. Entrants must be legal Florida state residents who are 18 years of age or older and have lawful access to the Internet and a valid e-mail address.
2. Employees of Oregon Television, Inc. and its stations, WOFL FOX 35, (“WOFL FOX 35”), WRBW MY 65, and Volusia County Fair (collectively, “Sponsor”), their affiliated companies, advertising and promotion agencies, and the immediate family and household members of each are ineligible.

How To Enter

3. No purchase is necessary to enter or win. Only one entry per entrant each day. The giveaway begins at 5:00 am local time on Monday, November 2, 2009 and all entries must be received by 11:59 pm local time on Monday, November 9, 2009.
4. To enter, log onto www.myfoxorlando.com and click on the ‘Contest’ link and follow through to the on-line contest entry page. Entrants will be asked to enter their email address and password to their myfoxorlando.com account. If entrants do not have an account with myfoxorlando.com they will be prompted to create one before they can register to enter the giveaway.
5. To create an account, enter your email address and create a password, then fill out an online form with your name, address, phone number and age. Once you are registered, you can enter the giveaway.
6. The Prize(s)

8. Five winners will win 6 tickets each to Volusia County Fair. The approximate retail value each prize is \$60. The prizes are provided by Volusia County Fair.

9. The winners will be notified by phone and e-mail on Tuesday, November 10, 2009. Five (5) attempts will be made to contact each winner. If a winner can't be reached, or does not respond to the attempted contact within 24 hours, that winner will forfeit the prize, and that prize will not be awarded.

10. The winners will be required to complete, sign and return a Certification of Eligibility and Release and claim the prize in a manner determined by Sponsor in its sole discretion when they pick up the prize or they will be disqualified. If a winner does not return the signed and completed Certification of Eligibility and Release and claim the prize within the designated time period, that prize will not be awarded.
